President's Message

The year 2012 marks the 40th Anniversary of the founding of the CLCT. From an initial 2 acre grant of property from Charlotte Craig, the holdings of the CLCT have grown to almost 2000 acres including both properties held in fee simple and by conservation easement.

Many of the properties that were obtained since 1972 were donated as gifts or at substantially reduced prices. Unfortunately, with the downturn of the economy nationwide including Canton, the CLCT does not foresee any large donations of property in the near future. In all probability, the CLCT will only obtain large pieces of property by purchase at substantially market value.

Any one desiring to be generous and wanting to restrict a donation to the CLCT solely for land acquisition may contribute at any time of the year. Please send your donation to Canton Land Conservation Trust, Inc. PO Box 41, Canton Center, CT 06020 and kindly mark your donation for land acquisition only. Stewardship Committee Needs Your Help

The Stewardship Committee under the leadership of Mike Gotaski and John **Pech** has continued its hard work. The highlights of its activities include the substantial completion of the project to place property and trail signs on most CLCT properties. Thanks to the tremendous efforts of Wayne Jekot each trail has been GPS mapped. A map for each trail may be found on the CLCT web site and also on a kiosk located at the head of each trail. Thanks Wayne for a job well done. Also thanks to Bill Duncan for uploading the maps to the web site.

On April 28, 2012 two Stewardship activities took place on the Smith tree farm. The first led by **Mike Gotaski** involved the planting of new trees on the Christmas tree farm and the second led by **Drew Stone** involved a trail crew that performed clean-up of the Charlotte Craig trail. **Christian Winkler** was one of the team planting Christmas trees. **Christian**, his wife **Michelle** and their 2 daughters moved to Canton last August and have become active in the CLCT including Trailblazer activities. Welcome **Winkler** family.

On May 19th **Drew Stone** led a very small work party that started clearing the trails on Sweetheart Mountain of downed trees and limbs. Unfortunately the work party only comprised **Drew** and **Wayne Jekot** so that additional work needs to be accomplished in the fall to completely clear the trails. Hopefully the fall trail crew will comprise more than 2 persons.



Membership

CLCT experienced an increase in members and membership donations from 2011 to 2012. From March 1, 2010 to February 28, 2011, we had 185 membership donations totaling \$17,135. For the same time period from 2011 to 2012. we had 202 membership totaling \$20,593. donations That represents a 9% increase in the count of memberships and a 20% increase in donation dollars. The time periods compared were chosen because the bulk of our donations occur between the months of December and February. Please continue to give generously and encourage others to do the same so that CLCT can continue to fulfill its mission of saving Canton's land.

Please help the Canton Land Conservation Trust continue to preserve open space for public access by renewing your membership for as little as \$25 per year. You'll get a tax deduction, continued access to increasingly rare open space, opportunities to participate in CLCT activities, and, best of all, the knowledge that you are maintaining wild areas for our children and children's children.

Sun Wind & Woodlands Hike

Sunday May 20th a small, but select group met with **Tom Noonan**, a biologist and teacher at Talcott Mountain Science Academy, for a hike originally planned to explore Sun, Wind and Woodlands' vernal pool. Due to the dry spring, the vernal pool was totally dried up. However, we did find water in a small pool by the red trail which must be fed by a spring or springs as it was well filled. No egg masses of either salamanders or frogs were found, but there were lots of pollywogs and a variety of beetle larvae along with a colony of blue flag iris. (Iris versicolor) A small pool of water off the Tom Perry trail was home to some green frogs and the small pond by the side of Breezy Hill Road had some very active newts. Although it was disappointing that the vernal pool had dried up, we were

amply rewarded by the number of birds we either saw or heard. A pair of Indigo Buntings were active in the parking lot, Oven Birds, Red-eyed Vireos and hard to locate Warblers were busy singing as were the Scarlet Tanagers. Among the wild flowers we saw were Pink Lady Slippers



(Cypripedium acaule), Fringed Polygala (Polygala paucifolia) and Indian Cucumber Root (Medeola virginiana). Had we not been so busy listening to the birds we probably would have found more flowers and no doubt a few mushrooms due to the recent rains.

Making your own backyard waterfeature

With some planning, modest outlay, and a bit of effort, one can easily make a water feature in the yard. In a couple of years you'd be surprised how natural it will look and the amount of critters that make it their breeding area. It is a good way to help the amphibian population build up. By using a small pump you can keep the water surface active and thereby

keep mosquitoes from breeding. The sound of moving water is great for your family to relax near. Precautions of course need be taken in cases where small children may visit.

One method of making a bond that gives very natural results uses Bentonite (well drilling mud/clay) to form an impervious pond floor.

The more common approach is to dig out a volume then line with thick plastic pond liner. Rivers and waterfalls can be added that make use of the topography of the site.

If you are interested in perhaps building your own water feature, you are welcome to contact me for some gratis advice and suggestions.
